Old Business/Reports

Land Use (including public access)

Baker -

- Boat Ramp A Request for Proposals (RFP) was completed. On track to issue a contract by the end of August
- Shoals Park No update in July
- Development Projects No update in July
- Maple Set Recreation Area- Improvements at John M. Bethea State Forest, the upper most access point to the river

Nassau -

- On Island
 - Brett's Waterway Cafe and Intercoastal Discussion about seawall potential for \$4 million in funding to assist with construction. Desire to not build it in segments
 - Boutique Hotel Plans are dependent on the construction of the seawall
 - Bioethanol plant No update in July
 - o Beach re-nourishment continuing into the Summer season

- Blue Bridge Mediation anticipated to begin soon; had to be rescheduled

- Charlton Camp Pinckney County Park Boat Ramp No update in July

Water Quality

- NPDES No new or renewed permits in Camden County or Charlton County
- Spanish Creek 319- Septic system repairs remain on hold until October. In the meantime, monthly water quality sampling is continuing. As expected during the summer months, E. coli levels are rising. The St. Marys Riverkeeper is scheduled to conduct eDNA sampling later this week to support ongoing monitoring efforts. Riverkeeper is currently working on the design of

- the Q8 newsletter, which is on track for distribution by the end of July. In addition, a new round of free pumpout services will be offered to households in the Nature Trail area to support septic maintenance and reduce environmental impact.
- Septic Think Tank Project is currently on hold, but there is still a need to do septic tank
 maintenance talks with any HOAs on both the Florida and Georgia sides of the river and its
 tributaries. There is a need to improve communication and education to help property owners
 understand septic tank maintenance needs and issues
- E&S spreadsheet
 - Florida requires a 25' buffer for wetlands, but not for surface waters. The committee continues to work towards a 25' construction buffer for Florida
 - Georgia does not have Nitrogen and Phosphorus (N/P) regulations
 - Committee members Cassie Turpin and Merrill Varn were given a site tour of the new Esplanade Golf Course by the project architect. During the visit, they observed that numerous ponds have been excavated, with erosion control fencing installed along all wetland areas. The excavated soil is being used to grade the entire property, directing runoff toward the ponds and away from both the wetlands and the river. All ponds are interconnected through underground piping, with two designated discharge points located in wetlands at a significant distance from the river. The architect was not aware of any specific water quality testing requirements related to the discharge. Cassie will follow up to determine whether testing is required and ensure appropriate measures are in place.
 - Tim Hiers, of White Oak Conservation, is still working on Best Management Practices (BMP) for golf courses.
 - Educational flyer for landscapers No update for July
 - Shared with Ace Hardware for distribution in Charlton County
 - Shared with Ace Hardware and Hometown Feed & Seed for distribution in Camden County
- FL TMDL Planning No update in July
- Georgia EPD Comprehensive Nutrient Permitting No update in July
- Folkston WasteWater Treatment Plant Contracts have been signed for equipment. The facility should be operational by December 2026 and complete in 2027
